**WELL SPRING GWPD 15 FORM: OBTAINING PERMISSION TO INSTALL,
MAINTAIN, OR USE WELL ON PRIVATE PROPERTY**

Filed In the Supreme Court of the Kingdom of Heaven: 8/4/2022

Residing Judge: YHWH the Supreme Judge over Heaven and Earth

Plaintiff: Ekklysia of our Lord and Savior Jesus Christ vs Satan, Area Principalities, and Humans governing the water rights World Wide.

Opening Statement:

Almighty King and Supreme Judge,

We come into Your Heavenly Courts today to file a GWPD 15, which will allow us (the sons of the Living God) to obtain permissions to install, maintain, and use new well springs that we desire to establish in the desert places.

- 1) First, we establish permission for rights to use the land and build upon it. We stand on Psalm 37:29 that states, "The righteous will inherit the land." We ask you to search our hearts and minds for any way that is displeasing to You. We offer these things up to You and our bodies as a living sacrifice according to 2 Timothy 2:15.

We ask You to forgive us for all sin, transgressions, and iniquities. We stand alone upon Your precious Blood that was the payment for our sins. We stand upon Your precious Blood that speaks on our behalf and that was the purchase price in order that we may be a Kingdom of Priests according to Revelations 1:6, 1 Peter 2:9.

We declare now, that as sons and priests, that we have the sole rights and authority over all ground and waters ways above ground and under the earth in (the world and specific areas named.)

We specify and name the following areas:

- 2) Supreme Judge, we come before Your Presence to confess the sins of our forefathers in regard to the well springs according to Jermiah 2. We acknowledge the charges that You have brought against the people.

The Lord God Almighty's Charges Against the People in Regard to the Well Springs

- a) "I remember the devotion of your youth, how as a Bride, you loved Me and followed Me through the wilderness, through a land not sown. Israel was holy to the Lord, the first fruits of His harvest; all who devoured her were held guilty, and disaster over took them."
- b) "What fault did your ancestors find in Me, that they strayed so far from Me? They followed worthless idols and became worthless themselves."
- c) "They did not ask, 'Where is the Lord, who brought us up out of Egypt and led us through the barren wilderness, through a land of deserts, ravines, a land of drought and utter darkness, a land where no one travels and no one lives?'"
- d) "I brought you into a fertile land to eat its fruit and rich produce. But you came and defiled My land and made My inheritance detestable."
- e) "The priests did not ask, 'Where is the Lord.'"
- f) "Those who deal with the law did not know Me; the leaders rebelled against Me. The Prophets prophesied by Baal, following worthless idols. Therefore, I bring charges against you again...and I will bring them against your children's children."
- g) "My people have committed two sins: They have forsaken Me, the Spring of Living Water, and have dug their own cisterns, broken cisterns that cannot hold water."

Supreme Judge, we come before You with contrite hearts. All Your charges against us are true. We have forsaken You; the Spring of Living Water and we have dug our own broken cisterns that do not hold water. We come and ask Your forgiveness. We repent and turn from our sins. We ask now to apply Your precious Blood to our sins. Wash us clean from all sins, transgressions, and iniquities. We stand upon Your promise in 1 John 1:9, "Therefore, if we confess our sins, He is faithful to forgive us and to cleanse us from all unrighteousness." We ask to be restored to a state of righteousness before You.

We seek Your face, O Lord God Almighty. We remember that You alone are God, the Sovereign King over all the heavens and the earth. We stand upon Your Word and ask that Your righteous scepter will be extended to us so that our voices may be heard on High. We declare:

Psalm 45:6 "Your throne, O God, is forever and ever. A scepter of uprightness is the scepter of Your Kingdom."

Genesis 49:10 "The scepter shall not depart from Judah, nor the ruler's staff from between his feet, until Shiloh comes, and to him shall be the obedience of the people."

- 3) We ask according to Your Word that the old and broken wells and cisterns be uprooted and destroyed. According to Psalm 60:7, all the ancient civilization that built these wells belong to You. They did so without your counsel and without Your permissions or will.
- 4) We ask according to Your Word that we may set up new well springs in the desert places. We ask that according to our authority as sons of the Living God, that we may act according to our kingdom rights and that You will grant us the FULL AUTHORITY to establish (with all permission obtained to drill, till, collect ground water), to maintain and record, to restrict the general public use, and to choose areas and locations that will serve best for wells. We ask for permissions to build.
- 5) We submit to the courts and file form 002 **A WELL TRANSFER AGREEMENT.**

This agreement made and entered into the Supreme Court of the Kingdom of Heaven on this 4th day of August, 2022 is between the kingdom of darkness run by Satan and his fallen ones and the Kingdom of God run by His righteous heirs. The agreement states that the Heirs of God, the EKKLYSIA is the sole owner of all the well spring properties, both

old, broken, and new. The agreement states that the EKKLYSIA and all representing it have full rights and access to oversee, manage, establish, build, and maintain the well springs. It also states the EKKLYSIA have the right to remove from the well spring properties any objects, obstacles, people, or fallen ones, their strongholds, fortresses, or camps that block, hinder, or prevent the well springs from operating at full capacity.

This agreement grants permission for Heavenly hosts to be discharged and assigned to the well spring locations on behalf of the EKKLYSIA. The assigned Heavenly Hosts have permissions to supply and maintain the wells, and to distribute the living waters therein to the nations. The permissions are given so that there may be an adequate and abundant supply of water to each individual and household living in the desert places.

6) We submit to the courts and file form 003 **PETITION FOR LICENSE FOR DRILLING WATER**

Sovereign Lord, we ask now that You will license the EKKLYSIA and all individuals therein, who are called by Your Great Name to be able to drill water, build water wells, and to be able to produce water for beneficial use which included:

- a) Domestic Use
- b) Irrigation
- c) Livestock watering
- d) Installation of wells and pumps
- e) Water treatment facilities

We ask for specialized Heavenly Hosts and men and women who will be tasked as “WELL SUPERVISORS”. We ask that positions in the following areas be granted.

- a) Well drillers
- b) Pump setters
- c) Water treatment installers in each State and Country

We ask these positions to be granted to protect this precious resource and Your Holy Name.

- 7) We submit to the courts and file **Amendment 004**. We ask for a double portion of Your Holy Spirit be distributed to those licensed so they will have wisdom, knowledge, and understanding to know where You desire to release the well springs. We ask that where they release the well springs that signs, miracles, and a demonstration of LIFE may follow as evidence that the Living Waters are flowing in that place.
- 8) Supreme Judge, I now ask that You consider this petition complete. I ask that as the EKKLYSIA commands and speaks forth that LIVING WATERS will break forth in the desert places. As we speak, so may You perform it immediately according to Your will. Thank You for Your judgement according to:

Isaiah 41:18 “I will make rivers flow on barren heights, and springs with in the valleys. I will turn the desert into pools of water, and the parched ground into springs.”

Isaiah 43:19 “Who turns the rock into a pool of water; the flint into a spring of water.”

Psalm 114:8 “For waters break forth in the wilderness and streams in the desert. The burning sand shall become a pool, and the thirsty ground springs of water.”

Numbers 21:1-18 “And from there they continued to Beer; that is the well of which the Lord said to Moses, ‘Gather the people together, so that I may give them water. Then Israel sand this song: ‘Spring up, O well! Sing to it! The well that the princes made, that the nobles of the people dug, with the sceptor and with their staffs.’”

- 9) I ask that with the release of the well springs that You also will release joy, and songs of joy.
